

ADVANTAGES OF HAVING A HOSTESS

Your boat hostess is an integral part of the boat crew and can make the difference between a good holiday and an amazing one..!

Besides keeping the boat clean inside, preparing your food and clearing after meals she is someone who will do her best to make your vacation more memorable and pleasant. This can include helping you choose the most suitable restaurants for your dinners, advice on places of interest where you stop off (you should not just read out of your guide book).

Whether you are interested in visiting the local sights, exploring the island, buying souvenirs or maybe just having some time on your own you cannot beat local knowledge.

Your hostess is more than aware of the fact that any boat offers a very limited space and she will provide you with enough privacy. She also recognizes when is the best time to start preparing your meals or to go shopping for groceries or take her time off...

The hostess will wash up and put away the dishes after meals and make the salon tidy.

Once a day she will check and clean your showers and heads.



When agreed, the hostess will make your bed in the morning. The guests can also arrange baby-sitting service if necessary, but this adds to the hostessing fee depending on the number of children and the time spent baby-sitting.

Since sailing is done on boats of different sizes and not always in the best of weather conditions, your skipper might also require some help. When required, the hostess will help the skipper during maneuvers (coming in and out of marinas, dropping anchor, refueling etc) and then finish her other duties. Remember, safety on any boat always comes first.

In addition the hostess has the right to her daily rest and privacy, of course, after her duties are fulfilled.

The boat hostess is not the person ultimately responsible for the safety of everyone on the boat, but is very aware of the significance of her presence on the boat as well as of her share of work.

Just the same, the guests need to recognize the fact that they are also just as responsible for providing normal conditions for the crew which can include providing food as well as good sleeping and hygiene conditions for their skipper and hostess.



LIFE ON BOARD

Dear guests,

in order to provide more pleasant and safer stay aboard yacht hereby we inform you of some general rules and responsibilites:

- Aiming to ensure all preparations are made on time, for charters including "all inclusive" package 15 days notice for dietary requirements and prefered rute plans is required.
- To reserve berthing space and to save time for visiting and enjoying Adriatic coast as much as possible, inform the captain about next prefered destination at least 24 hours in advance.
- Please do not smoke indoors. Smoking is allowed only outside the decks.
- To protect the interior flooring of the yacht, shoes may not be worn inside. High heels cannot be worn anywhere on the yacht as they damage the flooring. Please use "boat slippers".
- To guarantee yours and other peoples security, our captain is obbligated to respect the legal speed limit of 15 mph at 300 m from the coast (this applies also to the jet ski and jet dingy). Particular care should be taken near beaches and populated areas.
- Jet dinghy is used as the yacht's tender and may be driven only by the captain.
- Because of your security, it is obbligatory to wear life jacket at all the times when using jet ski. Please note that only persons carrying a valid licence are permited to drive jet ski so if you do not have one, express your wish to the captain and arrange the drive on jet ski with him.
- To ensure the safety of the passengers, the jet ski can only be driven at distance of 500 m from the yacht and stay within vision of the yacht.
- Adriatic sea is very attractive diving area full of caves, amazing rocks and lot's of unique seabed phenomena, but if you do not hold a valid diving licence

when diving you must be accompanied by a certified diving instructor. There are many professional diving centers on the Adriatic coast, so ask your crew to reccomand you the nearest one.

• If you plan to fish you need to have a fishing license. There are several places for purchasing fishing licence in Croatia so do not hesitate to ask your crew about it.

• During adverse weather conditions please accept captain's suggestions regarding your personal security and the security of the yacht. Because of his long lasting experience, the captain of the yacht will, at all times, have the final decision inwhere the yacht and the guests will be safeguarded from adverse weather conditions on the sea.

• Please note that due to insurance restrictions, the yacht cannot be driven at night.

• Please notify the captain immediately if you notice any problems with the yacht or its equipment.

• Unless all inclusive packages is ordered, the food for crew is not included in the charter price. Three meals a day (one warm) is to be organised either through yacht's cantine or by day fee of 50 euros.

• Unless all inclusive packages is ordered, the fuel is not included in the charter price. The yacht will be full on check-in in Šibenik and has to be full on check-out.

Thank you for understanding and obeying these general rules. We wish you a pleasant stay aboard yacht.
